

OFFICIAL RULES: UIU Daily Course Promotion at the Iowa State Fair August 11-21, 2022.

NO PURCHASE NECESSARY TO ENTER OR WIN. WINNERS must have a high school diploma or GED by August 21, 2022. Entry constitutes participant's full and unconditional agreement and acceptance of these Official Rules. Registrations for the Free Course Tuition Award will begin August 11, 2022, at approximately 9AM CDT, and will continue until August 21, 2022, at approximately 9PM CDT. At the State Fair's conclusion, 11 total winners will be drawn for a FREE UNDERGRADUATE OR GRADUATE CLASS that can be used Online OR at any one of our Center Locations.

1. WHO MAY PARTICIPATE: This drawing Award is open to the following individuals:

A) Anyone who holds a high school diploma or GED by August 21, 2022,

B) Current UIU enrolled student may enter the drawing to win a free class to take in one of the learning centers, online, or through the self-paced degree program.

Participants must also be either a United States citizen or permanent resident. Prior to accepting the prize as awarded, the winner must also complete an Affidavit of Eligibility and Liability Release and gain acceptance to UIU in accordance with UIU's admission standards.

If any of the participation requirements set forth herein are not satisfied by the winners, Upper Iowa University MAY conduct another random drawing of eligible entries and/or select an alternate winner.

2. HOW TO ENTER: Participants must fully complete an electronic or paper entry form available at the Upper Iowa University Booth at the Iowa State Fair and deposit the entry form where indicated at the Booth. The drawing for the winning entries (11 classes) will take place on or around August 25, 2022 on the Upper Iowa University campus in Fayette, Iowa.

This offer is only valid between August 11, 2022, and August 21, 2022. One entry per household per day. All duplicate within the same day will be null, void and disqualified, including any attempts to enter more than once by altering personal information. Upper Iowa University has no responsibility for any incorrect or inaccurate transcription, lost, late, misdirected, damaged or

illegible entry forms.

If, for any reason, this tuition award give-away is not capable of running as planned, including tampering, unauthorized intervention, fraud, or any other causes beyond the control of UIU, which corrupts or affects the administration, security, fairness, integrity or proper conduct of this promotion, Upper Iowa University reserves the right to cancel the promotion. All entries become the property of UIU, and will not be returned.

3. PRIZE: UIU will award one (1) free course consisting solely of tuition for a course taken in one of UIU's centers, online, or through the self-paced degree program. The prize must be used toward tuition for one of Upper Iowa University's undergraduate or graduate classes at a center, online, or self-paced degree program on or before fall semester 2023. The tuition award recipients **must also gain acceptance to UIU** based on standard admission requirements. Failure to gain acceptance to UIU will result in forfeiture of the tuition award.

This award is for tuition only and does not include books, personal computer or any other miscellaneous student fees. No monetary funds will be transferred to the student, but rather a transfer of tuition credit will be made from the UIU Business Office on behalf of the student to establish tuition payment. The total value of each award shall not exceed \$1875 for the 2022-23 academic year and will be increased accordingly for those students who do not enroll until fall semester 2023 as tuition increases are approved by the UIU Board of Trustees. There is no substitution or exchange of this scholarship; and transfer can only take place from a winning parent or guardian to a son, daughter or dependent high school or college student.

The winner is solely responsible for all taxes, fees and other miscellaneous costs or expenses relating to the scholarship. Winner of tuition award will be determined by the daily random one-time drawings from all eligible entries submitted within the designated promotional period. The drawing and announcement of the randomly selected winner will be posted online at www.uIU.edu.

Odds of winning depend upon the number of eligible entries received during the entry period. The winner need not be present to win. The winner will be notified by phone, e-mail and/or certified mail within 10 business days of the selection process.

4. ACADEMIC ELIGIBILITY IS AS FOLLOWS:

Winners must meet the following academic requirements for admission into UIU:

New applicants must have a high school diploma or GED before enrollment to UIU.

5. GENERAL CONDITIONS:

Employees and those with agency relationships to Upper Iowa University and their immediate families (defined as spouses, children, parents, siblings, in-laws) and persons living in the same household of such employees and agents are not eligible to participate.

The winner will be required to complete an Affidavit of Eligibility and Liability and Publicity Release prior to accepting the prize. If the winner fails to execute and return the required forms within ten (10) days, the award will be forfeited. All decisions of Upper Iowa University are final. Winners are required to apply and enroll for classes before the fall semester 2023 otherwise winners forfeit their prize.

As a condition of participating, the winner hereby grants to Upper Iowa University permission to use his/her name, likeness, persona and other biographical information for advertising and other uses without compensation or prior approval unless prohibited by law.
