

SL - 702.01.A, Residency Requirement Waiver

Off-Campus/Commuter Request Form

SL-702.01: Residency Requirement Policy

All students are required to live in University residence halls. Students who meet at least one of the criteria below may seek a waiver of the residency requirement, through which they can request to live off campus.

The following criteria are accepted when seeking a waiver of the residency requirement and requesting to live off campus:

- Lives in primary residence within 45 miles of the Fayette campus (verified via Google Maps) for two years prior to enrollment; parents' or guardians' names must be included in the request
- Has completed at least 90 credits
- Is a transfer student to UIU and has completed at least 48 (non-UIU) credits
- Married and/or has dependent children
- 22 years of age or older
- Military serving or (honorably discharged) Veteran

Students who fail to take up residency or move off campus without acceptance of the residency requirement waiver will be assessed a financial penalty of \$5,000.00 per year, for the duration of the residency off-campus until they meet one of the criteria above.

Off-Campus/Commuter Request Form

The Off-Campus/Commuter Request Form is located on the myUIU portal. Those seeking to live offcampus must submit their request 30 days prior to the start of Session 1 or Session 3. All requests to live off-campus are reviewed on a case-by-case basis. Requests in which at least one of the above criteria is not met are rarely granted.

Once a student is approved for a residency requirement waiver, it is for the remainder of their time at UIU, unless they decide to move back onto campus at some point after approval. If a student decides to live on campus, they will need to complete another waiver form for any future plans to live off campus.

Please note that if you are receiving the Peacock Promise Scholarship, you are required to live on campus. Should you still decide to live off-campus, you will lose your Peacock Promise Scholarship, and your financial aid will be adjusted accordingly.

Waivers of the housing residency require available via the Residency Requirement Waiver Form. Those seeking a waiver must do so 30 days prior to the start of Session 1 or Session 3. All requests to live off-campus are reviewed on a case-by-case basis. Requests in which at least one of the above criteria is not met are rarely granted. Once a student is approved for a residency requirement waiver, it is for the remainder of their time at UIU, unless they decide to move back onto campus at some point after approval. If a student decides to live on campus, they will need to complete another waiver form for any future plans to live off campus. Acting as the policy owner, the Director Residence Life and Chief Conduct Officer is responsible for answering questions regarding the application of this policy. Students who fail to take up residency or move off campus without permission will be assessed a financial penalty per year for the duration of the residency.
